FROM THE SECRETARIAT

Dear Friends,

I would like to thank you for your support of the Australian Catholic Social Justice Council throughout the year. Each year at this time I find myself reflecting on the major challenges we have faced and the countless works for justice initiated by individuals, parishes, religious congregations, dioceses, and through national agencies and networks. To me they all capture the something of our recent celebration of the Year of Grace, when we were invited to 'contemplate his face' and to 'start afresh from Christ'.

In the most vulnerable people and families we serve, we see the face of Christ. Like those who stood beside Jesus during the most difficult times of his earthly life, we share in his ministry; bringing comfort, standing in solidarity, and speaking out for the oppressed.

Even before he was born, Jesus and his family were threatened. As the bishops said in their Social Justice Statement this year:

'From the beginning, the Holy Family found itself in trouble and danger. The spirit of hope was central to their survival. Mary faced disgrace because she was pregnant out of wedlock (Matthew 1:18-25). Jesus was born in a stable because there was no room for his family at the inn (Luke 2:6-8). The young family were forced by Herod's wrath to become refugees (Matthew 2:13-23).'

That gospel account of the Flight into Egypt and the massacre of the innocents serves as a reminder of the tyrannical regimes that still exist around the world today. It also reminds us of the conditions of deprivation and fear that would cause any family to flee their homeland with little but the hope of some compassion from strangers in another land.

Time to end the detention of children and their families

It is a concern that Australia's response to the desperation of the relatively small number of asylum seekers arriving in Australia's waters has been to excise the whole nation from its migration zone.

Speaking after the recent meeting of the Australian Catholic Social Justice Council, Bishop Christopher Saunders expressed concern over the detention of children and their families.

'That asylum seekers, including children, have now been sent to Manus should set the alarm bells ringing. Having witnessed first-hand the conditions in Australia's detention centres, and following Amnesty reports of the crisis on Nauru, we hold grave concerns for their wellbeing,' he said. On their recent visit to Nauru, Amnesty found inappropriate and ill-equipped facilities, overcrowding, leaking tents in monsoon conditions, and detainees suffering from physical and mental ailments. They said the conditions on Nauru are cruel, inhumane and degrading.

The ACSJC holds that the 'tactical decision' to excise Australia from its own migration zone does not relieve us of our obligations under the Refugee Convention and the Covenant on the Rights of the Child. The Government may claim the excision removes these asylum seekers from our jurisdiction and relieves us of our obligation under international law. But can a country excise itself from the spirit of the law it signed? Surely it cannot deny the moral commitment it made when it became a signatory to these international treaties.

As stated by Bishop Saunders, 'No child should be detained indefinitely in any onshore or offshore facility. No person should be detained indefinitely in an environment we know causes long-term harm.

'It is hard to fathom the Government's expenditure of hundreds of millions of taxpayer dollars on indefinite offshore detention. This "no advantage" policy is sure to cause harm but it cannot guarantee its policy objective of deterring desperate people.'

The ACSJC has called on the Australian Government to release all children and their families from immigration detention whether that is on the mainland or in these offshore camps. (refer: http://www.socialjustice. catholic.org.au)

Is Australia a good global citizen?

Earlier in November, the Australian Catholic Migrant and Refugee Office reiterated the Church's grave concern over the proposal to excise the whole Australian territory for asylum seekers who arrive by boat. The policy places boat arrivals in a precarious legal position and denies them the legal right to ask Australia for protection due to their mode of arrival.

ACMRO director, Fr Maurizio Pettená, said, 'Australia has an exceptionally high level of regulation across our borders. Nonetheless, there will be times when people seeking asylum by boat will challenge this and our level of compassion. We should not give in to these challenges by disregarding our respect for human rights and the Refugee Convention.

'Australia is not immune to the conflict and persecution affecting those in other parts of the world. We are part of the global community and must act accordingly. The excision policy has disturbing ramifications for all other nations that have signed the Refugee Convention.

'We need to be cautious of the example we set for the rest of the world. If other nations choose to bypass the Convention then, as humanitarian crises emerge, people will have no place to go for protection and far more will have to travel longer distances to seek asylum.

'We need to reflect whether these restrictive policies contribute towards achieving justice and peace in the source countries caught up in the trials of war and ethnic violence. The right to emigrate is essential for people caught in humanitarian crises as their survival often depends on their capacity to escape.'

The Australian Catholic Migrant and Refugee Office maintains that all countries who are signatory to the Refugee Convention must unequivocally uphold the right of people to seek asylum,' said Fr Pettená. Children and families forced to take flight

A recent report by the International Federation of Red Cross and Red Crescent highlights the very conditions causing people to flee their homelands.

The 'World Disasters Report 2012' shows that a growing number of people are displaced by conflict, violence, persecution and political upheaval, natural disasters, and large-scale development projects. Last year, 72 million people were living as forced migrants.

Acting CEO of the Australian Red Cross, Michael Raper, said, 'The issue of refugees and asylum seekers tends to cause great debate in Australia but of the tens of millions of people around the world displaced by conflict, persecution, disasters and development last year, less than half of one per cent came to this country.

'Right now the world is facing a humanitarian crisis of forced migration in Syria where more than 1.2 million people have fled their homes due to the fighting and around 340,000 refugees have crossed into neighbouring Jordan, Lebanon, Iraq and Turkey. There is a real risk people fleeing the conflict in Syria will join the 20 million forced migrants worldwide who are living in a state of prolonged displacement.'

Mr Raper says that policies allowing forced migrants, including asylum seekers, to live and work in the community, are far more humane and sustainable than detention. The report notes that the growing resistance of politicians and citizens to supporting people who have been forced to flee their homes is perhaps the main impediment to providing better humanitarian and longer-term support to these highly vulnerable populations. I am among many Australians fortunate enough to have never faced the conflict, violence or disaster highlighted in this Report. But many of our fellow citizens have - some in recent times and others in earlier generations. As an Australian citizen, I feel proud that this country has provided a new home and the opportunity to start afresh for so many who have sought refuge here. And I feel humbled when I think of all the gifts I have received in return - the gift of new friendships, the sharing of cultures and histories, and the multiculturalism of modern Australia.

Australia's spirit of generosity towards those seeking refuge is written in our history. So is the contribution of generations of migrants who have been just as generous in building up this nation and making it their home. With the good will that characterises the Season of Christmas, we might consider how we can bring that proud history back to life. Think of how the children and families in Australia's detention camps share intimately in the story of the Holy Family. We might pray that the spirit of Christmas will have a transforming influence in the lives of our political leaders - so that they will respond with compassion to individuals and families who now find themselves enduring prolonged indefinite detention on Nauru and Manus Island.

On behalf of the Australian Catholic Social Justice Council and its Secretariat I wish you and your families a happy and holy Christmas and all the best for the year ahead.

STATEMENT: BISHOPS SUPPORT ROYAL COMMISSION

On 12 November, the Australian Catholic Bishops Conference issued a statement supporting the announcement by Prime Minister Julia Gillard of a royal commission into child sex abuse. 'This is a serious issue not just for the Catholic Church but for the whole community,' the statement says. 'As

Catholic bishops and as individuals we share the feelings of horror and outrage which all decent people feel when they read the reports of sexual abuse and allegations of cover-ups. Over the past 20 years, there have been major developments in the way the Church responds to victims, deals with perpetrators and puts in place preventive measures. In addition, there is a much greater general awareness of the

issue of paedophilia in the broader community. Sexual abuse of children is not confined to the Catholic Church. Tragically, it occurs in families, churches, community groups, schools and other organisations. We believe a royal commission will enable an examination of the issues associated with child abuse nationally, and identify measures for better preventing and responding to child abuse in our society.' STATEMENT: WAKE UP CALL ON HOMELESSNESS

The Australian Council of Social Service has

expressed alarm at new Census data showing an increase in the level of homelessness in Australia and called for a concerted national effort to address the worsening problem. The ABS has shown the rate of homelessness in Australia was 49 persons for every 10,000 persons enumerated in the 2011 Census, up 8% from 45 persons in 2006. 'Clearly we are not doing enough to deal with homelessness. The latest figures are a wake-up call that one of the principal ways to deal with homelessness is to take measures to tackle the nations' affordable housing crisis, which is causing so much strain and forcing people into poverty,' said ACOSS CEO Dr Cassandra Goldie. 'It's also a sign of the extent of strain being experienced by community support services, especially those supporting women escaping violence; young people, including those leaving care; Aboriginal and Torres Strait Islander peoples; and people from culturally and linguistically diverse backgrounds. About three guarters of the increase in the overall homelessness estimate to 2011 was accounted for by people who were born overseas,' she said. PETITION: END THE DETENTION OF CHILDREN!

Australian Young Christian Students (YCS) are calling on the Prime Minister and Australian Parliament to uphold rights of Child Convention & end the detention of children.

Around 590 Children are currently locked up within Australia in Immigration Detention, and with the recent amendments to the Migration Act their wellbeing is set to get even worse. The Parliament has not ensured that a guardian for the children will be sent offshore, so there is no-one who can advocate for their needs. No legal safeguards have been put in place to ensure their safety and, as high school students of the same age, members of the YCS have serious concerns for their wellbeing.
