FROM THE SECRETARIAT

Dear Friends,

You will be aware from earlier briefings that Australian citizen, David Hicks has been detained without trial in Guantanamo Bay since 2001. He has allegedly been subjected to intense interrogation and abuse during that time.

Human rights organisations, law societies overseas and in Australia, the churches and religious organisations and many individuals have campaigned against the circumstances of detainees there. The International Red Cross earlier described the treatment of detainees at Guantanamo as being 'tantamount to torture'. Pressure is been brought to bear on the Australian Government to demand Mr Hicks's release or immediate trial before a proper court.

The U.S. Supreme Court this year decided against the U.S. Government's proposed system of military tribunals to try detainees. The grounds for this decision were principally that the President had exceeded his authority in setting up the tribunals and that the arrangements did not meet the standards set out in the Geneva Conventions.

This briefing provides an update of developments concerning the detention of David Hicks and other detainees as well as calls for the facility at Guantanamo Bay to be closed.

New Military Commissions

The U.S. Congress has now approved a system of tribunals similar in some respects to the one disallowed by the Supreme Court, and this approval was signed into law by President Bush on 18 October.

It is likely that there will be further delays as the new system is set up, new charges are laid and, most likely, a series of appeals against the proposed system is launched again.

The Attorney-General, Mr Philip Ruddock, has been reported as being willing to consider requesting the return of David Hicks should the U.S. not proceed quickly with trial arrangements. In mid-August, Mr Ruddock was reported as saying that he'd try to have David returned to Australia if no charges were laid by November. It is difficult, however, to know how long it will take to put this tribunal system in place. And it is unclear whether the Australian government will find legal and other delays acceptable. In effect, the fact that there is no clear time by which the tribunals will be in operation means that Mr Hicks is facing further indefinite detention.

In addition, there are serious concerns about the standards of justice of the proposed tribunals. Such concerns include lax rules of evidence that would allow hearsay and information gained under coercion, as well as the exclusion of the accused during some proceedings.

More calls for justice for David Hicks

There is growing support for the closure of the detention facility at Guantanamo Bay and for the provision of basic justice for detainees.

In an article in *The Age* on 10 October Catholic Archbishop of Sydney, George Cardinal Pell, ACSJC Chairman Bishop Christopher Saunders and Anglican Archbishop Peter Jensen called for an end to his indefinite detention.

The Cardinal said, "I have long been disturbed by some aspects of David Hicks' situation. From all accounts we owe him no special favours at all, but he has a right to be brought to trial more quickly than has happened and now as quickly as possible."

Bishop Saunders said, "If he has a case to answer he should be tried without further delay by a competent and independent tribunal with all of the protections of the rule of law that Australian citizens would expect, compliant with the Geneva conventions."

Archbishop Jensen said of David Hicks's circumstances, "It is both unjust and undemocratic and also an abuse of human rights. It goes against the freedoms and rights for a fair trial that have been developed in jurisprudence over centuries. David Hicks has the rights to a fair trial and it should be immediate." Other distinguished citizens and organisations have raised their concerns.

After attending an address by David Hicks's military lawyer, Major Michael Mori, in early

November, National's Senator Barnaby Joyce said that the due process of law was not being followed and that if the proper processes meant that Mr Hicks should be sent home "then Mr Hicks had to be sent home." Senator Joyce said, "Hicks has been in jail five years – two years in solitary confinement – it is not unreasonable to say this must come to a head and a decision must be made". At their meeting in Western Australia on 10 November, the State and Territory Attorneys-General signed the 'Fremantle Declaration' and called on the Commonwealth Government to take action to ensure David Hicks is immediately brought to trial. The declaration demands all Australian governments uphold the right to a fair trial, the principle of *habeas corpus*, the prohibition on indefinite detention without trial, the prohibition of torture, access to rights under the Geneva Conventions, the separation of powers and the prohibition of the death penalty. The Attorneys General followed this with a letter to Attorney-General on 27 November. The letter included photos from an unnamed source of David Hicks's cell which cast into doubt the Federal Government's claims about the acceptability of his treatment in detention. The Attorneys' letter states that "the use of a cell of this type to confine Mr Hicks for eight months is inhumane" (refer: http://www.theage.com.au/news/national/orange-crush/2006/11/27/1164476136512.html)

On 9 November, an independent legal opinion was issued by the Hon. Alistair Nicholson QC, Peter Vickery QC, Prof. Hilary Charlesworth, Prof. Andrew Byrnes, Gavan Grifith QC and Prof. Tim McCormack. The distinguished jurists and academics maintain that the proposal to conduct a trial of David Hicks before the Second Military Commission would not be consistent with the decision of the recent U.S. Supreme Court and that a Military Commission established under the Military Commissions Act of 2006 would contravene the standards for a fair trial under Australian law. The new ecumenical organisation, the Centre for an Ethical Society, was launched by former Chief Justice, Sir Gerard Brennan, on 17 November. Sir Gerard spoke of David Hicks when he said that our laws and policies need to be invigorated with the Christian value of the Good Samaritan:

"The outcasts are, by definition, denied their dignity... And see how we have tolerated, for five years now, the barbarous treatment of the Australian David Hicks in Guatanamo Bay, still waiting to be charged, it seems, with an offence under a law yet to be specified and tried by a process which mocks the civilized sense of justice. Do not blame governments alone. This could not have happened if our society were infused with Christian values," Sir Gerard said. (refer: http://www.cathnews.com/news/611/doc/cets-brennan.htm)

Pax Christi Australia [NSW] has written urging the Prime Minister to increase efforts to secure a just and humane resolution to David Hicks's situation and expressing concern that he has been "deprived of the centuries-old right of habeas corpus review that is embedded in Australian Law and that he is subject to the unilateral power of executive detention by a foreign power." Pax Christi has called on the Australian Government to act immediately and decisively to end this indefinite detention of David Hicks.

The Catholic Justice and Peace Commission of the Archdiocese of Adelaide have organised a petition to the Senate calling for action to end the indefinite detention without trial of this

Australian citizen. Thank you to those around the nation lending support to this petition. While the closing date for the receipt of petitions was 30 November, the Editor of Online Catholics has suggested that people might also write letters conveying the substance of the petition to the Attorney General (refer: http://www.onlinecatholics.com.au/issue132/commop.php)

Amnesty International Australia also has a campaign. It is a letter writing/email campaign; urging people to write to Prime Minister Howard advising the Federal Government to act to ensure David Hicks has access to a fair trial or is released. Breaking News

Concluding their November Plenary Meeting in Sydney, the Australian Catholic Bishops Conference has issued a statement calling on the Australian Government to act now and to act decisively.

The Bishops say that David Hicks has been held with "no ability to contest the accusations against him. There is now heightened concern for his physical and mental health, in conditions which reputable human rights agencies have said are tantamount to torture."

"A continuation of the current situation is not acceptable.

"Australia has a duty as a member of the world community to uphold standards of justice and decency. Historically, Australia and its allies have a proud record in supporting these principles, both within and outside their borders," the Bishops say.

The statement calls on both the Australian and U.S. Governments to resolve this issue urgently. (refer: http://www.acbc.catholic.org.au/latest.html)

SERIES PAPER: CHOICE FOR WHOM? A DISCUSSION OF THE 2005 INDUSTRIAL RELATIONS LAWS

Catholic school teachers to join IR protests

Following criticism by the Prime Minister of government school teachers who planned to join national protests against workplace laws, unions for teachers in Catholic and independent schools have confirmed that thousands of private school staff are also expected to participate.

Sri Lanka is in a state of civil war and facing a major humanitarian crisis, the head of Caritas Australia said, in the latest call for a ceasefire and the establishment of an international emergency committee to look for solutions to the violence.

Churches challenge rich countries on greenhouses gases

Rich countries must reduce their greenhouse gases drastically, a World Council of Churches representative told the UN Climate Conference on Friday but churches in the developing world are not waiting to launch action in their own regions.

Housing debt, consumerism taking toll: Archbishop Hickey

The real estate boom may be making Perth an investor's paradise but Archbishop Barry Hickey said that the associated problems of bankruptcies and mortgagee sales are causing marriage failures and even suicide.

Catholic priest and nun human shields against Israeli bombing

American Catholic priest and nun spent several hours at the home of a Palestinian militant acting as human shields to protect the house from destruction by Israeli military forces.

Pastoral care under threat at Christmas Island, said Bishop Grech

The isolated location of a new detention centre being constructed at the cliff-surrounded western tip of Christmas Island will make it "virtually impossible" to provide adequate pastoral care, said Bishop Grech.

Govt incentives encourage job agency rorting, report said

The Government's system of rewarding job agencies that delay help to the unemployed until they are out of work for more than 12 months exacerbates long-term unemployment and provides incentives for the agencies to "stretch the ethical boundaries", a Catholic Social Services report said.

Church must fight for common good, former Chief Justice said

Speaking at the launch of an ecumenical social justice centre, former Chief Justice Sir Gerard Brennan said that churches need to win "hearts and minds" to the idea of a common good based on the dictum that "the money you keep locked away is the money of the poor".

Wadeye Indigenous community appeals to Pell

A Northern Territory Indigenous leader, Tobias Ngambe from the Wadeye Indigenous community west of Darwin met with Sydney Cardinal George Pell to seek additional funding for a disadvantaged local school.

SA drops planned ban on religious discrimination law

The South Australian government dropped a planned ban on religious discrimination following opposition to the proposed law from the main Christian denominations over fears that they would be prevented from converting non-Christians.

Christian groups in G20 solidarity protest

Christian anti-poverty campaigners planned to set up a tent outside the G20 Summit as finance ministers and central bank governors from 19 countries and the European Union arrive in Melbourne

Rabbi outraged by Brennan "ghetto" comments

Jesuit Fr Frank Brennan apologised for hurt caused by remarks describing conditions in Bethlehem as "ghetto-like" after a Melbourne rabbi said he "felt sickened" by what he characterised as the human right activist's "politically charged speech".

Refugee fears mount over Indonesia treaty and high court decision

The Brisbane Catholic Justice and Peace Commission voiced concern about the implications for West Papuans of a pact between Australia and Indonesia while Edmund Rice Centre said that a recent High Court decision will put refugee lives in danger.

Human trafficking worse than slave trade, Cardinal claims

International human trafficking has intensified to the point that it is now worse than the historical

slave trade from Africa, the head of the Pontifical Council for Justice and Peace, Cardinal Renato Martino, said.

Church's best kept secret revealed

A new website promising to provide in plain English "almost everything" the faithful wanted know about the Church's social teaching was launched by Jesuit provincial, Fr Mark Raper.

Indonesian prosecutors allege man planned hundreds of Christian decapitations An Indonesian man now on trial for his life for the beheading murder of three Christian girls had planned hundreds more killings, prosecutors told a court in Poso, Sulawesi.

Ban political donations, said Edmund Rice Centre

The Edmund Rice Centre director Phil Glendenning weighed in on the debate over a ban on political donations, saying that a \$10,000 jaunt with a political leader could fund half the cost of an apprenticeship for a young Australian.

Bathersby calls Christians to ecological conversion

As thousands marched in capital cities across Australia to call for measures to combat global warming, Brisbane Archbishop John Bathersby told a rally that he believes that it is not possible to be Christian and not care about the environment.

Media violence desensitises young people, said youth advocate

Influential bands that advocate rape are impacting on young minds, said youth advocate, Fr Chris Riley, as it is revealed that one youth in the notorious Werribee DVD is a student at a Geelong Catholic college.

Slammer not the answer, say NZ bishops

With New Zealand incarceration rates second only to those of the US, what is needed is a new approach, not new prisons for the country's growing prison population, New Zealand's bishops said.

God "not wholly owned" by any political party: Rudd

Speaking at the launch of Jesuit Fr Frank Brennan's latest book on religion and politics, Labor frontbencher Kevin Rudd accused Coalition MPs of failing to address the "destructive impact that market fundamentalism on the family, the community."

December 10 Human Rights Day

10 Point Plan for Human Rights

- Accept personal responsibility for change, no matter how small. Don't assume that someone else will do it. Don't be complacent. Even small things like refusing to laugh at a racist joke can make a difference.
- **Reflect on your own behaviour**. Reflect on the cultural practices or beliefs that you find confronting or difficult. It is healthier to name and discuss the issues that you find difficult than to try and be saintly.
- **Identify what you have got to give**. It may be time. It may be specific expertise. It may be a shoulder to cry on or a sympathetic ear. It may be money. Everyone can do something and this may change at different times in your life.
- Act in your own context. For example, has anybody in your workplace raised the desirability of a workplace code of values and ethics? If not, perhaps you could do it. Once people have discussed desirable ways in which people should treat each other in the workplace, it is a short step to raising human rights more broadly.
- Collaborate. There is strength in partnerships and strategic alliances.
- **Join. Network. Lobby. Advocate**. Tell politicians what you think. To recycle an old slogan: 'Keep the bastards honest.' Sign petitions. Write letters. If you can, make use of the Internet and email to reach people.
- **Treat everyone with respect**. Respect is more important than compassion or sympathy, because respect is based on familiarity and understanding. And respect ensures that people retain dignity.
- **Be inclusive**. Once you have a good relationship with people, it becomes easier to think about how social justice and human rights issues can be raised.
- Maintain your rage. Also maintain your hope, your optimism and your sense of humour.
- And finally, celebrate your successes. Not only does this make you feel good but it also energises you for more work.

December 10 Prime Minister Paul Keating's Speech

Australian Launch of the International Year for the World's Indigenous People Redfern Park, Sydney, 10 December 1992

... In truth, we cannot confidently say that we have succeeded as we would like to have succeeded if we have not managed to extend opportunity and care, dignity and hope to the indigenous people of Australia - the Aboriginal and Torres Strait Island people.

This is a fundamental test of our social goals and our national will: our ability to say to ourselves and the rest of the world that Australia is a first rate social democracy, that we are what we should be - truly the land of the fair go and the better chance.

There is no more basic test of how seriously we mean these things... More, I think than most Australians recognise, the plight of Aboriginal Australians affects us all...

This is perhaps the point of this Year of the World's Indigenous People: to bring the dispossessed out of the shadows, to recognise that they are part of us, and that we cannot give indigenous Australians up without giving up many of our own most deeply held values, much of our own identity - and our own humanity.

Nowhere in the world, I would venture, is the message more stark than in Australia. We simply cannot sweep injustice aside... And, as I say, the starting point might be to recognise that the problem starts with us non-Aboriginal Australians...

The message should be that there is nothing to fear or to lose in the recognition of historical truth, or the extension of social justice, or the deepening of Australian social democracy to include Indigenous Australians.
