FROM THE SECRETARIAT

Dear Friends,

You will be aware that pressure over the case of David Hicks has been building on the Australian and US governments over the past three months.

A growing number of public figures, many of them associated with the Coalition parties, have made similar calls to that of the Australian Catholic Bishops' Conference for David Hicks to be given a prompt and just trial or released from Guantanamo.

The mounting pressure has brought about a change in the government's line. It now acknowledges that the delay of five years has been inappropriate and has made public that it is consistently pressuring the US to bring David Hicks to trial. The US has indicated what charges it is seeking to lay, but they must be approved by military judge. There are now undertakings that Mr Hicks would serve any sentence in Australia and that his time in detention would be taken into consideration at sentencing. A trial, however – especially a hasty one – may not bring him justice.

There is still widespread criticism of the standard of justice in the proposed military tribunals. Former Prime Minister Malcolm Fraser has pointed out that, while the tribunal rules seem to prohibit evidence obtained through torture, “other rules make it likely that convictions may be achieved on such tainted evidence”. Second or third-hand hearsay evidence is to be permitted, he says, and the defence cannot test it or challenge its accuracy. The defence may be unable to see some classified evidence or know how it was obtained (refer: <http://www.abc.net.au/news/opinion/items/200702/s1849110.htm>). Further delays in the trial process will prolong the detention and a court that does not ensure adequate protections of the rule of law will not ensure a standard of fairness that we would rightly expect for ourselves and our fellow citizens if we had a case to answer before a court.

BISHOP SAUNDERS REITERATES CATHOLIC BISHOPS' CALL FOR DAVID HICKS

In early February, Australian Prime Minister John Howard said he might have secured Hicks' release any time during the last five years but did not because that “would not be fair” to U.S. authorities. Bishop Saunders called Hicks' continued incarceration an “affront to human dignity and unacceptable to anybody who holds in high regard due processes of law and human rights in any real democracy. In December last year my brother bishops and I called for David Hicks to be given a prompt and just trial or returned to Australia. Well, that time has come – action is required now,” he told Catholic News Service. <http://www.catholicnews.co/data/stories/cns/0700842.htm>

POVERTY STUDY – ‘DROPPING OFF THE EDGE’

Extreme social disadvantage in Australia is real and measurable. Its endemic to a small number of locations in this country, and it can be fixed, according to major new research to be released on Wednesday. “Dropping off the Edge: the distribution of disadvantage in Australia” is the most comprehensive national study of its kind. The report, which is a joint project with Jesuit Social Services and Catholic Social Services Australia, is the third in a series of reports on the issue, written by researcher, Professor Tony Vinson, from the University of Sydney. The report finds that just 1.7 per cent of postcodes and communities across Australia account for more than seven times their share of top rank positions on the major factors that cause intergenerational poverty. Nearly 400 Mass-goers from Sydney’s Mary Immaculate Manly parish signed a last-ditch appeal to the Government to prevent plans to deport a young Sierra Leone man whose sister was raped to punish him.

Cappo committee in call for SA mental health revamp

The South Australian government committed to implementing 33 recommendations from the Social Inclusion Board chaired by Adelaide’s Msgr David Cappo which called for sweeping changes to the state’s mental health care system.

Columban calls for Catholic stand on GM food

The use of new genetic engineering technologies in the production of food crops poses unknown health risks, Columban Fr Charles Rue said. He called for an informed Catholic voice on genetically modified foods in the lead up to the NSW election.

Christian activist accuses Govt over security bungle

Bryan Law, one of four members of a Christian peace group arrested in 2005 at the Pine Gap spy base, accused the Federal police of violating security laws after they provided the protesters with classified video footage of the arrest scene.

Church "behind the game" on energy: Bishop Toohey

Bishops Commission for Justice and Service chair, Bishop Chris Toohey, said that the Church is

"behind the game" in terms of energy use with many buildings old and energy wasteful.

Catholic media group calls for action on Pacific "crisis"

Concluding a Melbourne assembly, representatives of Catholic media outlets in the Pacific region have called on the media to play a "robust" role to help alleviate "the spiralling social, economic and political crisis that plague many of our nations".

Priest condemns re-opening of Aust mine in Philippines

The parish priest of St Florentina on Rapu Rapu island in the central Philippines condemned the re-opening of an Australian-owned mine on the island after the government lifted a 15-month suspension of operations owing to earlier tailing spills.

Caritas wants to hold leaders responsible for aid promises

Two leading international Catholic development networks were targeting the world's richest and powerful countries with a campaign to "make aid work" which aimed to ensure that international leaders meet promises to eliminate poverty in the world's poorest countries.

Act now on climate change: US bishops to Congress

It is time for the US to come together to address the moral, human and environmental dimensions of global climate change, the head of the US Catholic bishops' international policy committee said in a letter to American legislators.

Sudanese refugee cuts "abominable": Sydney bishop

Outgoing Sydney Vicar for Immigration, Bishop David Cremin, slammed a plan by new Immigration Minister Kevin Andrews to cut the intake of refugees from war-torn Sudan as "abominable".

Face truth about fossil fuels, Bishop Toohey says

Responding to a major UN report on climate change, Bishops' Commission for Justice and Service chair Bishop Chris Toohey said that it was time to face the "uncomfortable truth" about reforming the production and use of energy.

Death penalty violates Gospel, right to life: Vatican

Renewing its attack on the death penalty, the Holy See said that it is difficult to justify its use today and warns that the practice is an affront to human dignity and "the evangelical teaching of forgiveness."

Priest accuses NZ Govt over refugee double standard

Dominican priest, Fr Peter Murnane accused the New Zealand government of double standards after a Catholic Iranian man was denied asylum while an Iranian gay man facing similar threat of persecution was accepted as a refugee.

Uniya warns over low Australian engagement in Asia-Pacific

A new study by Uniya Jesuit Social Justice Centre found that there is still significant goodwill in the Asia-Pacific region towards Australia but the Centre's director Mary Bryant warned that the level of Australian involvement in the region remained "worryingly low".

Priest calls for "new partnership" in community services

Saying that not much has changed since Jesus first told the parable of the Good Samaritan, Catholic Social Services chairperson, Fr Joe Caddy, called for a new government, church and community partnership "to create a genuinely fairer and better world for all".
