### FROM THE SECRETARIAT

Dear Friends,

#### Social Justice Sunday - 28 September

As Social Justice Sunday approaches, now is the time to place your orders for the Australian Catholic Bishops' Statement. Bishop Christopher Saunders, Chairman of the ACSJC has called on all Catholics and people of good will to consider the affluence of our nation against the circumstances of those who continue to experience great hardship.

'No matter how well the economy performs, the health of our society can be judged by the treatment of its most vulnerable citizens. Following years of prosperity, Australia has the means to act for the common good and with a special concern for the poor. We are challenged to really consider what sort of society we want now and for the future.'

Reflecting on the 2008 Social Justice Sunday Statement, *A Rich Young Nation - The challenge of affluence and poverty in Australia*, the Bishop poses the questions: 'What values characterise our daily lives? Have we become obsessed with economic success and material acquisition? Do we recognise those in need and our obligation to do something about it?

'For Christians, the Word of God constantly reminds us of our obligation to the poor. Each time we gather at Eucharist we give thanks for the saving presence of Christ who died for all. As the Holy Spirit transforms the gifts of bread and wine into the Lord's body and blood, so we are renewed in our commitment to be Christ's witnesses to the world.

'The Holy Father has affirmed the importance of our shared commitment to the poor when he said of the Church:

*...love for widows and orphans, prisoners, and the sick and needy of every kind, is as essential to her as the ministry of the sacraments and preaching of the Gospel. The Church cannot neglect the service of charity any more than she can neglect the Sacraments and the Word. (Deus Caritas Est, n.22)*

'This Social Justice Sunday, we are all challenged to consider how we can be the Good News to the poor,' Bishop Saunders says.

In the 2008 Statement, the Bishops renew the call they made in 1992, as Australia emerged from a global recession:

'Once again we call for justice for those afflicted by poverty in our affluent society. We call on all political and community leaders, as they put in place policies based on well thought-out strategies for the years ahead, to bear in mind the circumstances and needs of the most vulnerable members of our society...

'It is important that together we face the reality of poverty and seek ways to address it, however difficult that may be at a personal or societal level. As a country that espouses the value of the 'fair go', it is time to act for those who have missed out on the benefits and opportunities that the good economic times have provided this nation,' the Bishops say.

### Indonesian executions “torture”: Priest

Describing their deaths as “torture”, a Catholic priest who witnessed the shooting executions of two Nigerian drug traffickers in Indonesia says it took seven minutes for them to die.

Tony Blair’s sister in law and an 81 year old Catholic nun joined two peace ships organised by a Melbourne man, Michael Shaik, which broke through Israel’s blockade of Gaza to deliver relief supplies.

Catholic Earthcare chair and Wilcannia-Forbes Bishop Chris Toohey said that it is urgent for Australians to get involved in addressing the degradation of the Murray-Darling basin.

### Child removal threshold ‘too low’: ACU academic

ACU lecturer Dr Patricia Hansen told a child welfare conference that parents are losing custody of their children when “they could be given a second chance”.

### Hickey slams WA Labor over homeless

On the eve of state elections, Perth Archbishop Barry Hickey criticised Western Australia’s Labor government for failing the homeless while the Broome diocese also highlighted housing issues in the region.

### Sri Lankan bishop: ‘Help war refugees’

Jaffna Bishop Thomas Savundaranayagam appealed for assistance after nearly 200,000 people were forced to flee their homes after renewed fighting between Sri Lankan government forces and Tamil Tiger rebels.

A Palestinian refugee, Akram al Masri, who was deported from Australia in 2002 been killed in his homeland less than six months after Australian authorities refused him a visitor’s visa.

The National Council for Building a Better Fiji co-chaired by Suva Archbishop Petero Mataka and coup leader Commodore Frank Bainimarama endorsed a People’s Charter for Change seeking an end to the country’s “coup culture”.

The Edmund Rice Centre welcomed the Australian Government's decision to launch a Pacific Guest Worker Scheme but it said that the Government also needs to address indigenous unemployment here.
